#### **Mr Caesar Wong 黃信安先生**

Caesar is a professional accountant, certified tax advisor, and trusted China business partner. He was with Andersen, PwC, EY and Deloitte for the past 24 years before joining RSM Hong Kong. Caesar was seconded to Shanghai back in 1994 and was relocated to Guangzhou to witness the development of the member zones of China (Guangdong) Pilot Free Trade Zone.

Caesar has solid experience in delivering practical solutions to China and cross-border tax and business projects. He is also specialized in China investment services, government services, tax risk management and tax controversy solution services. For examples, he works with investors to conduct location studies as well as due diligence reviews in merger and acquisition projects, advises on tax efficient investment structures and operational models, and incorporates pioneer companies in China's Free Trade Zones. He helped an international hi-tech group to secure the first advance pricing agreement in Shanghai in 2001, which was also the first one on intra-group service income in China. He also assists taxpayers to arrive at mutually acceptable solutions to tax audit cases.

Caesar supports policy studies and drafting, and is a popular speaker at government policy consultation meetings, important conferences and trainings for officials. His professional appointments include:
