Recent Tax Developments in Hong Kong and the Challenges under the New Tax Treaty Benefit Claim Procedures in China (Course Code 課程編號: 2617)

Highlights: 課程重點:

In order to boost the economic vibrancy in Hong Kong, the Chief Executive, in her Policy Address has unveiled new tax measure to reduce the burden on the companies, including a two-tiered profits tax system that would lower the profits tax rate to half of the current standard rate on the first \$2 million of profit. Besides, bills have been gazetted for the introductory of the tax regimes for corporate treasury centres and aircraft financing and leasing businesses in Hong Kong.

On the international perspective, Hong Kong has always been a common investment platform for investment into China due to the commercial and geographical reasons and the potential enjoyment of treaty benefits (e.g. reduction in withholding tax rate on dividends and capital gain tax exemption). Nevertheless, it is common that Hong Kong companies are purely investment holding companies lacking sufficient commercial substances. With the recent development and changes in the China's domestic tax requirement (e.g. Public Notices 'PN' 7 and 60) and Base Erosion of Profit Shifting in the international tax context, proving commercial substance in Hong Kong companies has become a necessity in order to enjoy the double tax treaty benefits and prevent the potential challenges from the tax authorities.

In view of these, SCAA has invited PwC Tax Controversy Services professionals, Mr. Kenneth Wong, Mr. Horace Wan and Miss Vicky Wong, to share with you the recent tax development in Hong Kong and the challenges under the new tax treaty benefit claim procedures in China.
