### Navigating the Latest HKEX ESG Reporting Requirements and Best Practices (Course Code 課程編號: 1524)

#### Highlights: 課程重點:

On 19 April 2024, Hong Kong Exchanges and Clearing Limited (“HKEX”) issued a regulatory announcement regarding the conclusions to its consultation on the enhancement of climate-related disclosure requirements under its ESG framework for listed companies, and provides guidance for issuers to support the implementation.

Additional climate-related disclosures under the new Part D will be introduced to Appendix C2 of the Hong Kong Listing Rules. The existing ESG Reporting Guide will also be renamed as ESG Reporting Code (“ESG Code”). The amended listing rules will come into effect on 1 January 2025 and phased approach will be adopted to facilitate the implementation.

This Webinar aims to provide issuers and ESG practitioners with valuable insights into the new HKEX ESG requirements, enabling a smooth transition to the enhanced climate-related disclosure.
