The Office of the Privacy Commissioner for Personal Data (PCPD 個人資料私隱專員公署) published the 'Artificial Intelligence: Model Personal Data Protection Framework' (Model Framework) to provide internationally well-recognised and practical recommendations and best practices to assist organisations to procure, implement and use AI, including generative AI, in compliance with the relevant requirements of the Personal Data (Privacy) Ordinance (PDPO), so that organisations can harness the benefits of AI while safeguarding personal data privacy.
