The Stock Exchange of Hong Kong Limited (the Exchange) regularly reviews its corporate governance framework to ensure it remains effective and continues to enhance governance quality among Hong Kong listed companies. On 19 December 2024, the Exchange released the Consultation Conclusions, detailing the key amendments to the Code and related listing rules. These amendments will take effect on 1 July 2025, with certain transitional arrangements in place.

This seminar, presented by BDO specialists, will provide a concise overview of the finalized updates and their implications for issuers. Participants will gain insights into the new requirements and best practices for compliance, ensuring they are well-prepared for the upcoming changes.
