### Introducing IFRS for SMEs Accounting Standard (Third Edition)

#### Highlights: 課程重點:

On 27 February 2025, the International Accounting Standards Board (IASB) released the third edition of the IFRS for SMEs Accounting Standard (the "Standard"), introducing significant updates following its second comprehensive review.

These updates aim to align the Standard with certain full IFRS Accounting Standards, including IFRS 15 Revenue from Contracts with Customers, IFRS 13 Fair Value Measurement, IFRS 3 Business Combinations, IFRS 10 Consolidated Financial Statements, and others. The updated Standard is effective for annual periods beginning or after 1 January 2027.

In this webinar, the speakers will provide an overview of the major changes and practical considerations for its application.
