



香港華人會計師公會慈善信託基金

香港華人會計師公會註冊之慈善信託基金「香港華人會計師公會慈善信託基金」(THE SOCIETY OF CHINESE ACCOUNTANTS & AUDITORS CHARITABLE TRUST)，已於二零零八年五月十九日完成登記及經香港稅務局確定慈善信託團體地位，可根據《稅務條例》第88條獲豁免繳稅。借此感謝香港稅務局各領導之幫忙，使本慈善信託基金得以在短時間內成立。

「香港華人會計師公會慈善信託基金」設立之目的，主要是用以促進教育、救助貧困及支援有需要之人仕而設，現任信託人為2008年香港華人會計師公會會長楊志偉、副會長蔡淑蓮、秘書長陳美寶及財務長吳榮輝。

在2008年5月12日四川省北部阿壩州汶川縣發生之黎克特制8級地震，造成超過陸萬多人死亡，受災人數在數以仟萬人以上，重災區面積龐大。經本會緊急呼籲各方人仕及會友捐助賑濟四川大地震災民，在短短一個月內，「香港華人會計師公會慈善信託基金」從香港華人會計師公會、各理事、會員、各方友好人仕、及與ACCA為此賑災舉辦之培訓課程，已籌集得超過港幣玖拾萬元，本會即時捐贈香港紅十字會在中國地震之救災工作。在此再次感謝各位之慷慨捐助。
